C. TERMS AND CONDITIONS

- 1. You are to present your National Identity card or Passport on the day of the exam (and a photocopy of it, if it's your first cbe exam at IMIT). You shall not be admitted into the examination room without presenting one of these documents.
- 2. You are responsible for determining your eligibility to take the paper you have indicated above.
- 3. If the wrong exam and/or stream are programmed for you as a result of your error in the table under B 7 above you shall lose the fees paid.
- 4. The centre authority may find it necessary to adjust your exam day or time after receiving your booking, for example; if seats are all filled for the day and/or time you have indicated above as your preferred time/date, or other circumstance arising after your booking. The centre authority shall contact you to confirm the closest available day/time.
- 5. On the day of the exam, you must be at the exam centre at least 30 minutes before the start time. You will not be allowed to take the exam if you come late and you will lose the exam fees paid.

6.2 Refund of Fees

- 6.2.1 There shall be no Refund of paid fees.
- **6.2.2** Candidates who face the following circumstances shall be considered for possible refund of part of the fees, **provided they had notified the CBE center authority at least 3 days before the exam date** and upon presentation of valid justifying evidence:
- **Force Majeure**; the candidate is a victim of a serious accident, assault or other extenuating circumstance.
- **Hospitalization** of the candidate.
- **Death** of a parent, spouse, child or sibling of the candidate.
- A call to Military service or an obligatory professional duty call.

The candidate shall apply for the refund, attaching documentary evidence of their claim. If the candidate's application is granted, they shall be refunded as follows:

FA1, MA1, FA2, MA2 = 38.000FCFA; FAB, FMA, FFA, F1, F2, F3 = 48.000FCFA; F4 = 54.000FCFA. The candidate may wish to transfer refundable funds to a new exam booking.

- **6.2.3** Unfortunately, refunds are not possible for circumstances arising less than 3 days to the exam date.
- **6.3 Rescheduling of a booked exam**: Once an exam is booked, it must be taken. Candidates who miss an exam or come late for the exam shall forfeit the examination fees paid.
